# **EXCELSIOR LIBRARY UPDATE**

Excelsior residents really rallied to support the Excelsior Library renovation and the library is scheduled to open sometime this summer.

This community has raised nearly \$40,000 for furnishings and equipment for the library so far. That includes over \$6,000 raised by the calendar sales, and funds raised the Diane Di Prima poetry reading, the Valentine Dinner Dance, and the party at Wendy Smither's house. And, thanks to solicitations by Supervisor Gerardo Sandoval on behalf of the Excelsior Library, an additional \$5,000 has been pledged.



Another benefit," Night of New Music" is scheduled for Friday, April 16, 8 PM at the Ocean Avenue Presbyterian Church, 32 Ocean Avenue. Tickets are \$10 regular admission and \$5 for seniors and students. Call (415)587-1100 for more information.

An added value is the Spaghetti Feed fundraiser for the Ocean Avenue Presbyterian Church from 6:30 to 7:30 in the church basement immediately preceding the new music concert on April 16. The cost is\$7 for adults and \$3.50 for children.

# MAYOR OWNERSHIP ASSISTANCE PROGRAM

Mayor Newsom outlined several homeownership programs administered by the City. "The City is back in the down payment business", remarked the Mayor, noting that \$8 million in down payment and second loan funds have recently been made available for affordable first-time homeownership opportunities. Additionally, the City offers mortgage credit certificates that make homeownership affordable by reducing a household's total tax owed.

San Francisco's homeownership assistance programs are targeted to low- and moderate-income families. For the down payment programs, families of 4 can earn no more than \$95,000. Families with slightly higher incomes (up to \$158,000) are eligible for the other City homeownership programs. City down payment and second loan assistance programs

### MAYOR GOES ABOVE AND BEYOND—TOWN HALL MEETING

#### Fellow Excelsoirans

Since Gavin Newsom took office in January 2004, his administration has focused on a broad range of issues that affect San Franciscans daily, like homelessness, public safety, quality of life, jobs and economic development. He has worked toward one goal: a safer, healthier and stronger San Francisco. He is proud of what he has achieved but he needs to know if he is on the right track. That means listening to San Franciscans like us.

Lionel Brazil, Angelique Mahan, Claire Zvanski and David Hardaway and other District 11 residents were given the opportunity to participate in *SF Listens*. We were invited to initiate an unprecedented dialogue between City Hall and the people of San Francisco.

Over the course of the four weeks, Mayor Newsom has or will convene four meetings across the city in each of San Francisco's distinct quadrants: west (Districts 1,4 and 7); southeast (Districts 9,10 and 11); central (Districts 5,6 and 8) and north (Districts 2 and 3). Each meeting will be comprised of San Franciscans, invited and selected at random. By the project's end, as many as 600 city residents will have provided direct input on the city's priorities. And in so doing will help shape San Francisco's future.

Historically, public input on the budget has come late in the process - largely happening once the budget has been submitted to the Board of Supervisors. *SFListens* is changing that. *SFListens* will provide Mayor Newsom with our input about budget priorities before he submits the budget to the Board of Supervisors in June.

These issues, familiar to us all, which were presented to us for discussion include:

**Homelessness** - This continues to be among the most pressing problems facing San Francisco. Efforts to address the problem are increasingly focused on moving away from temporary shelter toward permanent housing.

**Housing** – Just as permanent supportive housing is the key to ending homeless as we know it, creating more affordable housing is the key to making San Francisco a more livable city for low-and moderate-income residents.

**Public Safety** - Crime in San Francisco is a real and urgent problem. Every resident of San Francisco deserves to feel safe in their homes and workplace. At this time, San Francisco must be ready to face the on-going threat of natural disasters and terrorism.

**Quality of Life** - Improving the quality of life enjoyed by all residents in every neighborhood will make San Francisco a more livable, vibrant city. This means focusing resources on the clean street and parks, creating more open space, reducing air pollutants, revitalizing neighborhood commercial corridors and developing a sense of community.

**Jobs & Economic Development -** Revitalizing San Francisco's economy through job creating and business growth is essential if we are to make it through these difficult economic times. We must grow an economy that is diverse and stable.

**Education** - Safe, successful schools are an essential part of a strong healthy community. Good public schools translate into strong workforce and help retain families in the City.

**Children, Youth and Families -** Children help make San Francisco a more vibrant and livable city. But the high cost of living, particularly the high cost of home ownership, is making it increasingly difficult for families to live in the City.

**Health Care** - Securing quality, affordable health care is necessity for our City. Uninsured employees most often work for small businesses, work flex-time, are self-employed, or are very low-income wage earners who cannot afford health coverage. Affordable, accessible health care is key component of a healthy city. While San Francisco has made a start at improving health coverage for our residents, much more needs to be done.

As a collective group we were also asked to present any other issues that were not on this list. One area that resonated thoughout our quadrant and the Western quadrant was **Government Accountability.** This was quite a surprise to the Mayor.

The goal of *SFListens* is to begin an in-depth conversation across San Francisco about the issues we face, how those issues should be prioritized and which strategies San Franciscans like you believe will make real change. After prioritizing and we could only use the top three, the Southeastern quadrant choices were Housing, Public Safety and Government Accountability.

Unlike average town halls, which are often focused on speeches, question-and-answer sessions or panel presentations, *SFListens* focuses on discussion and deliberation among real San Franciscans, utilizing technology to capture and synthesize this information in real time.

### GIGANIC SPRING CLEANING IN MAY

Coming in May there will be a gigantic Spring Cleaning for the district; Excelsior residents can take advantage of Sunset Scavenger's Gigantic 3 boxes. Three large containers will be available for the recycling, composting, and dropping off of bulky items on Saturday, May 7<sup>th</sup> at the Crocker-Amazon Playground (Moscow St. at Italy). The event runs from 8 am to noon, and residents may bring any large items (such as mattresses, yard waste, furniture, appliances, etc.) and drop them off free of charge. The Computer Recycling Center will also be on hand to recycle computer equipment (limit 5 computers per household).

Hazardous materials, such as paint, tires, motor oil, and batteries, are not accepted.

We are also excited to introduce the "Clean City Garage Sale" – all reusable items dropped off at the Sunset Scavenger's Gigantic 3 event will immediately be made available to the general public. One persons junk is another person's treasurer.

This event coincides with the SF Clean Team's campaign to keep District 11 clean, green, and forever beautiful! The Clean Team, a partnership of the San Francisco Clean City Coalition, the Department of Public Works, and the Recreation and Park Department, clean parks, schools, and neighborhoods of the city district by district. May brings the Clean Team to District 11,

can provide up to \$100,000 in loans that are deferred for 40 years (or upon sale). City rehabilitation loan programs can provide up to \$150,000 (for a 2-unit residence) or \$75,000 (for a single-unit residence). All programs have additional underwriting and eligibility guidelines.

At the conclusion of the final meeting, the information gathered will be complied into a single report that will detail the collective recommendations of *SFListens* participants from across the city. This report will be then posted on the Mayor's website.

#### Some key facts about the budget:

The Constitution of the State of California and the City Charter require San Francisco to adopt a balanced budget. This simply means that: Total City Revenues = Total Cost of City Services

A slow economy, rising labor costs, and revenue losses due to State budget reductions have generated a S102M projected deficit for fiscal year 2005-2006.

The Mayor and the Board of Supervisors must reduce expenses and/or increase revenues in order to balance the budget. However, the City Charter and State law restrict how revenue may be generated and specify what the City must spend money on.

Total San Francisco budget: \$5 billion. Most is "non-discretionary" or expenditures mandated by law, such as Muni, the Airport, and the Public Utilities Commission.

Discretionary Amount of San Francisco budget: \$1.15 billion. The part of the budget the Mayor and the Board of Supervisors may control and use to balance the budget.

What's in the Budget? - 52 Departments: Department budgets range from less than \$1 million to over \$100 million; their staffs range from less than 20 to over 1,000. With multiple departments serving a similar need and priority such as public safety, health or infrastructure.

#### WHO IS INVOLVED IN THE BUDGET PROCESS?

**The Mayor:** The City's Chief Executive who carries out policy through the budget. Must present a balanced budget to the Board of Supervisors each spring.

**The Board of Supervisors:** The City's legislative body that reviews, amends and approves the Mayor's budget, ensures citizen views are part of the budget process, sets policy direction for the City.

**Controller:** The City's Chief Financial Officer who projects how much revenue the City has available to fund the budget, prepares reports and other technical aspects of the budget, and ensures that the City meets financial obligations legally and correctly.

**City Departments:** Department heads and their staffs who deliver public services, carry out policy, and manage the budget. During the budget process they prepare program and financial information and answer questions from policymakers and the public. Public input at the department level is very important for those with concerns about specific programs or spending plans.

**Commissions:** An organization that holds public hearings, approves the department's budget proposal to the Mayor, and advises the Mayor and the Board of Supervisors on policy matters.

**You:** Citizens have a voice in the budget setting process through meetings such as *SFListens*, in public hearings at City Hall and in supervisorial districts. Contact your district supervisor's office to learn when hearings may be held in your district.

**HOW DOES AN AVERAGE CITIZEN VOICE THEIR OPINION ON THE BUDGET?** They can participate in SF Listens! They can call your District Supervisor and participate in public hearings. Or they can write or call your elected official, or the Department providing a service of particular interest to you.
